	RR opened the meeting as Chairman and thanked the public for their attendance.	
1	APOLOGIES FOR ABSENCE Heidi Stevens and Richard Prior both sent their apologies	
2	DATA PROTECTION Councillors confirmed that they have read and understood PPC’s GDPR policies; that they do not hold any personal data in any manner contrary to those policies; and that they agree to disclose any known, potential, or perceived data breaches.	
3	DECLARATIONS OF PECUNIARY AND NON-PECUNIARY INTEREST IN ITEMS ON THE AGENDA There were no Declarations of Interest by Councillors pertaining to agenda items or in terms of pecuniary and non-pecuniary interest.	
4	SUBJECT UNDER DISCUSSION – A REDUCTION IN THE SPEED LIMIT ALONG A280 / LONG FURLONG MP proposed, DT seconded. RR expressed reservations about reducing the speed as accidents could be and have been caused by slow-moving vehicles being overtaken. MP recognised that a reduction in the speed limit is not easily enforced and may not resolve the issues. A parishioner suggested that there should be a reduction in the speed limit along the whole of the Long Furlong and not just through the village. She suggested that double white lines could also be used at the corner by Myrtle Grove to prevent overtaking and reduce accidents. DT to enquire with highways and report back. Resolution 1 - PPC to support a reduction in speed from 40mph to 30mph jointly with Clapham Parish Council Resolution 2 – fact-finding to establish whether or not the A27 could be reduced from 60mph to 50mph.
